Shoes of Memory

Vancouver Holocaust Education Centre 50 - 950 West 41st Avenue, Vancouver Show runs until May 30

I recently visited the Shoes of Memory exhibit by Jenny Stolzenberg, a British ceramics artist who has chosen the discarded shoes of Jewish prisoners as the subject for her art. The shoes look beaten down, mouldy and broken, evoking images of forced marches, the hardships and the brutal conditions experienced by the wearers. As I moved closer to the collection, my eyes were immediately pulled to a young child's pair of red shoes. Who would not be prompted to picture a small child, proudly showing her new red shoes to all who would take the time to admire them? And yet, as I focussed longer on those red shoes, they spoke to me of the tragic story of a young life cut so short. This is a powerful and emotional exhibit. I recommend that you take the time to see it.

Following is the artist's statement.

I can create beauty out of the unspeakable because my work is a tribute. It is about paying homage to the memory of people whose lives were destroyed. The deed was ugly, but the victims were not.

Jenny Stolzenberg is a second-generation British ceramicist, living and working in London, England. Her father, William Powell, was a Holocaust survivor. Born in Vienna and arrested before the war for distributing Communist literature, Powell spent 18 months in Buchenwald and Dachau. After his release, Stolzenberg's father immigrated to England. The rest of his family perished in the Holocaust. Powell rarely spoke of his experiences. He passed away in 1990.





Stolzenberg began researching the Holocaust in order to try and understand her father's experiences and her family history. She visited Auschwitz and says that, "I was most taken aback not by the piles of shoes and suitcase which I had expected, but more by the mounds of human hair, spectacles, shaving brushes and artificial limbs, which I had not." She chose to make ceramic shoes precisely because of her reaction to the items. While some of the other objects in the piles were more shocking, Stolzenberg felt that the shoes had the potential to be transformed into evocative and compelling works of

To create the Shoes of Memory, Stolzenberg did extensive research into styles of the period. A unique pattern was cut out of clay for each shoe and then hand-moulded, glazed and fired. The result is an attempt to rescue the shoes, and victims, from the anonymity of the piles at Auschwitz by restoring a sense of identity and therefore individuality to the victims.

One of Stolzenberg's main inspirations for Shoes of Memory is a passage from the novel *Fugitive Pieces* by Anne Michael: "I imagined that if each pair of shoes could be named, they could be brought back to life."

Skin Deep: Dualism Of Wearable Art

Gallery of BC Ceramics May 4 to 31 Opening reception: May 4, 6 to 8 p.m.

Take a stroll down Cartwright Street on Granville Island on the evening of Thursday 4th May, and you can expect to see a number of live mannequins welcoming you through the doors of the Gallery of BC Ceramics. Though not a normal sight at 6 p.m., Granville Island is renowned as a central venue for entertainment, and specifically for its host of performance artists in the form of unusual characters. But just what do live mannequins have to do with


> ceramics, you may well ask? The answer is . . . "Wearable Art.".




The Gallery of BC Ceramics will proudly be hosting the work of Sarah Douglas and Roxanne Gagnon for their May exhibition. The two Vancouver-based artists have collaborated on a previously less familiar theme for ceramic work, that of jewelry, to promote a body of work relating to fashion. This is a contemporary and dynamic display of work by new artists. The work includes necklaces, rings, wrist cuffs and bracelets, at the heart of which is a belief in art objects as social, accessible, functional statements of personal identity, as well as personal possessions. The concept surrounding the show incorporates the idea that art needn't be restricted to the home. Performance artists will be modeling the jewelry on the opening night out-

side the gallery, while others will be making themselves at home in the interior setting of the exhibition space amid a lively atmosphere of music and people.

Also featured in the exhibition is sculpture by Roxanne Gagnon, which serves to illustrate an alternative understanding of the concept of 'wearable art'. Her pieces take on body forms and

Jeremy Hatch: Tree House

Tree House is an exhibition consisting of a sculpture of a life-size cherry tree with a tree house, made of porcelain. Artists have often been inspired by the world of children and by nature. In this installation, artist Jeremy Hatch references both and much more as well.

Porcelain is a type of hard semi-translucent ceramic generally fired at a higher temperature than glazed earthenware, or stoneware pottery. It is white, but mildly translucent and can be decorated to provide colour. It is usually associated with delicate objects and is thought of within the craft and art communities as something fragile and exquisite. Yet porcelain is also very strong and durable. It has utilitarian capabilities and has been adapted for industrial and other pragmatic purposes. It is this disjunction, or dialectic, within the medium itself that has also inspired the artist.

The tree house was a monumental undertaking for the artist. To create this work he made approximately 30 separate plaster molds of a tree that were then cast in

porcelain. The porcelain sections are then arranged over an interior steel armature that supports the work. All in all, it took almost one full year to create. Hatch's work is enfused on many levels with sly and articulate humour. In an earlier work, a life-size children's swing-set that was also made of porcelain, he subverted the expectations of what was handmade versus what was mass-produced. In replicating a mass-produced, factory-made object in porcelain, he elevated it to the realm of "fine art." While his sculpture was - in certain respects - exactly like the object that he cast from, it was the





material and the fact that it was handmade that created the difference in how it was regarded and characterized.

In Tree House he further challenges our assumptions and expectations. In this case, the use of porcelain to create a replication of something from the natural world creates a dialectic referencing mass production and the vulnerability of nature. The tree and tree house have been "immortalized" - they are cast, frozen in time. Yet they are fragile and vulnerable to breakage and if toppled, would shatter into a million pieces. In this way, Hatch's work can be read as a poignant evocation of the fragility of our childhood memories and nostalgia for our past - our "roots" if you will.

This multilayered and impressive installation has wide-ranging appeal to a diverse audience. Hatch's Tree House celebrates a sense of freedom, of play and also reminds us of the potential of childhood and of dreams - providing we try creative means of realizing them.

Jeremy Hatch is a ceramicist and sculptor who holds a BFA from Emily Carr Institute and an MFA at the New York State College of Ceramics at Alfred University. He has attended residencies and exhibited his work throughout Canada and the United States. Jeremy currently employs a ceramic process of slipcasting porcelain to produce large unglazed sculptural installations. He has expanded his material investigations to incorporate rubber, plastic and fiberglass into his ceramic work. Hatch was the recipient of British Columbia's 2005 Visual Arts Development Awards.



ANNUAL GENERAL MEETING April 8, 2006

President's Report

2005 was a stellar year for the Guild. Celebrating our 50th anniversary with so many different events will make this a year to remember.

I would like to thank all the members of the Board, Sheila Morissette, Don Jung, Dave Kruyt, Matthew Freed, Jay MacLennan, Leon Popik, Amber Kennedy and Stephanie Craig, and Gallery Manager Brenda Beaudoin, for their hard work and strong leadership during the year. Special thanks go out, too, to our gallery staff members, the 50th Anniversary committee, to the many volunteers who continue, year after year to contribute energy and spirit, and to those who support our activities through donations in kind and money. Without these active members we would not be the strong organization we are today. Thank you everyone.

Gallery

In 2005, gallery profits rose by almost 30% from 2004 despite the continued trend of decreased tourism to Vancouver. Administrative savings resulted from management of supplies, office and exhibition expenses.

We continue to strive for excellent customer service. In a move to increase our local market, a database has been created to allow for informational mail outs and appreciation discount cards to valued customers. Gallery staff regularly re-arrange work to create a visually stimulating display of members' work.

Maintaining a positive working environment as well as building and encouraging staff knowledge and skills is reflected in the minimal turnover of our dedicated and committed staff.

The Gallery continued strong promotion and support for Guild programs and initiatives. On top of the standard enquiries and membership processing, in 2005 this included the extra 50th feature display shelves and the Managers 50 Favourites; co-ordination support for the Tajimi exhibit, BC in a Box and TransFormations. A substantial extra load for Gallery Manager and staff!

2006 Goals:

- Exhibitions that reflect a wide variety of ceramic possibilities and interests: home décor, top sellers, jewellery, musical show and guild touring exhibitions
- New website;
 - Reflect the mandate & aesthetics of the Potters Guild of BC and Gallery

- Marketing strategies; selective target advertising and strong PR in order to maintain growth of gallery profits
- Continued promotion and support for Guild programs and initiatives
- 50% of Gallery profits from this year to go directly towards 2007 Gallery goals and upgrades

Newsletter Communications

2005 was a very busy year with all the 50th anniversary activities happening. The guild's newsletter has continued to be a source of information connecting the guild, gallery, fellow potters and artists throughout the province of BC. We'll continue to use the newsletter and look for more ways to enable our Guild members to communicate to each other and to the public.

The content of the newsletter has been guided by Gillian McMillan, Martin Hunt, Carole Matecha and Andrea Maitland. They have been the key people putting the newsletter together. Many thanks to the terrific volunteer team of Rona Hatherall, Carole Matecha, Marie Smith, Lewis and Hazel Kennett, Linda LeBrun and Billy Wittman who ensure the newsletter gets sent out to everyone.

Advertising: We have steady regular and occasional advertisers to help defray the cost of putting out the newsletter. Accounts receivables were poorly handled with our previous accounting firm. A new system of invoicing has vastly improved our billing and payment situation. No rate changes are planned but a different payment model is being considered to further simplify the invoicing process.

Electronic Communications

E-mail Broadcasts: The broadcast e-mails have become a steady part of our communications efforts. They've come in very handy for those last minute reminders and announcements. It's very cost effective and is slowly and steadily becoming a larger part of the communications effort.

Newsletters by E-mail: We began sending the newsletter by e-mail to members who chose this option. This is a very cost effective way to distribute the newsletter, saving us printing and mailing costs and allowing more content and colour images. We encourage more members to receive the newsletter by email as this option develops more.

Website: Some significant plans like the members' web pages on the Potters Guild of BC website did not come to fruition this year. Hopefully we can address some of the technical issues and make it a reality in the coming year.

The events calendar has not been a very effective tool and will be removed. A simple list of pottery and clay-related events seems to be the way to go. The discussion board has been seldom used but keeping it in place is a minor effort. This can likely be dropped when the website is revisited.

What's in store for 2006

Website Re-Design: We have solicited some proposals to redesign and update the website. Get ready for a new look and feel to the www.bcpotters.com website.

New Communications Chair: Don Jung will be stepping down as Communications Chair after this term. He will be staying on to assist with the website re-design and as part of the communications team to maintain and update the website.

Newsletter Advertising: We will be looking at requiring pre-payment of Ads in the Newsletter for all new advertisers. Established, regular advertisers will continue with the current invoicing arrangement.

Webpages for members: We still believe this would be a good extension of the website and a benefit to the membership, so we'll aim to get this online in 2006.

Membership

In 2005, the Guild's membership base increased and revenue from membership was higher than projected. New members were reached as a result of the Guild's active year through the events surrounding the 50th anniversary and, in particular, BC in a Box. The current number of members is approximately 450 - an increase of 10% over 2004. Last year, the goal was set to make the membership function self-sustaining and one that broke even. It is projected that in 2006, membership will be a profit generating function of the guild.

50th Anniversary

BC in a Box: Initiated by Karen Opas, this exquisite exhibit attracted 150 participants and received rave reviews. With sponsorship by Orton and Greyhound, the exhibit opened in Port Moody and then travelled to Victoria, Salt Spring Island, Kelowna, Salmon Arm, Williams Lake, Quesnel, and Courtenay. Thanks to the many volunteers who assisted at each stop.

BC Potters shows: Heather Cairns arranged for four public galleries in North and West Vancouver to host ceramic exhibitions in celebration of the Guild's 50th anniversary. The participating galleries were - The Silk Purse, and Ferry Building Gallery, in West Vancouver; Seymour Art Gallery and CityScape Community Art Space, in North Vancouver. Five invitational shows were held throughout the month of May, with participation by over twenty-five Guild member, ceramics students from Capilano College and five West Vancouver High Schools. The Ferry Building Gallery offered a sold-out tour, hosted by Heather Cairns, visiting the four North Shore Galleries as well as taking in the "BC in a Box" show at the Blackberry Gallery in Port Moody.

Concurrent exhibits were held by the Fraser Valley Potters Guild at the Evergreen Gallery in Coquitlam; and a celebration of ceramics show curated by Coralie Triance was held at Crafthouse on Granville Island.

Transformations: Curated by Carol Mayer, jury assistance by Hiro Urakami and Darrin Martens, archival assistance by Debra Sloan, Source Book produced by Al Sather, other support by Keith Rice-Jones and Jinny Whitehead, Heather Cairns and Suzy Birstein. The show opened at the Burnaby Art Gallery on a beautiful August evening with a turnout of more than a hundred members. We received good press coverage and the gallery reported a very good turnout for the exhibit. A catalogue of the exhibit was produced and the Source Book was recorded onto a disc; both are available for purchase.

Published articles: Heather Cairns and Debra Sloan co-wrote the article "The Potters Guild of BC, The First Fifty Years -1955-2005: Origins of a Ceramic Culture". It was published in the Autumn 2005 edition of FUSION magazine, published by the Ontario Clay and Glass Association. Rachelle Chinnery wrote an article that was featured in the electronic version of Ceramics Monthly December 2005 – January 2006.

Tajimi Exchange Exhibit: 50 works by BC potters were displayed beside 50 works by Tajimi artists. The exhibition was located adjacent to the Mino International Exhibition and the World Expo in Aichi. In 2006 the exhibit will be displayed in our own gallery on Granville Island.

Managers' 50 Favourites: Working with past managers of the Gallery of BC Ceramics, Coralie Triance curated a show of 50 managers' favourites. This exhibit was displayed during the month of December at the Gallery of BC Ceramics.

Events and Fundraising

Markian Kyba, with Lolly Cook and a team of volunteers ran the popular raku firings held on Granville Island in June and July. Donations of bisqueware from members is always appreciated.

Made of Clay was held in June and participation was lower than the year before. It has been decided not to hold this event in 2006, but to take the time to review the format.

Twenty Lower Mainland volunteers ran a "Too Good for the Shard Sale" in the Lougheed Mall and were successful in raising \$5,000. These funds were used to cover expenses for the 50th anniversary.

Enquiries

Leon Popik responded to electronic enquiries and Jay MacLennan responded to telephone enquiries. As a cost and time saving move, it was decided to cancel the telephone answering service and redirect calls to the gallery. This action will ensure enquiries are dealt with in a more timely manner and will result in financial savings. Jay Maclennan leaves the Board this year.

Financial Report

Dave Kruyt - Treasurer

For the fiscal year ending December 31, 2005, the Potters Guild of British Columbia achieved a modest surplus of \$3,574. Gross revenues fell short of the budgeted expectation of \$394,500 by \$42,000. This shortfall in revenues was offset by a reduction in expenses from the forecast of \$386,800 to actual expenditures of \$349,000, resulting in the net surplus of \$3,574.

The following table illustrates the differences between our 2005 budgeted and actual results, and offers a comparison with the 2004 results.

Despite a drop in Gallery revenue of \$17,000 in 2005, its operations generated a net income of \$14,516. This was accomplished through a reduction in expenses of \$13,000. Several changes to the allocation of expenses were included in the 2005 statements. Rent and utilities became the sole responsibility of the Gallery. To offset the effect on the Gallery, staff time spent on Guild business was transferred to the Guild's statements along with 50% of the accounting fees. This was done to create a more realistic picture of the financial costs of both organizations and allocate the responsibility for the costs in line with the use of the service and the ability to determine its cost. The net effect was marginal as the increase to each was largely offset by a reduction.

In 2005 the Guild also transferred responsibility for accounting from Quantum Accounting to an independent bookkeeper, Nadine Simcoe. Nadine's efforts to rectify many outstanding issues and review internal controls have created a more responsible and responsive accounting process.

Guild financial results saw a significant drop in net income for the year. Despite an increase in revenue from membership dues, the overall revenue of the Guild fell by \$9,700. This was due to a shortfall in planned revenues from events, along with a few unplanned expenditures (most notably the BAG Exhibit). Many administrative costs were above plan, while there were also some significant savings in other costs. However, it is important to note that the 2005 budget was projecting a shortfall in Guild operations of \$13,800. The loss therefore is actually \$3,100 less than planned. The loss was also exacerbated by a extra-ordinary write off of bad debts of \$2,600, which if it had not become an issue would have seen the loss for the year at approximately \$8,300. Given that the intent of the Guild is to serve it members with the income form the Gallery subsidizing those services, the overall financial results were, while lower than anticipated, still a success.

The 2006 budget has taken a conservative approach in estimating revenues given recent trends on Granville Island. While the overall projection is a loss of \$6,500, the intent of the budget is to develop longer-term objectives and build toward those goals.

With careful financial management and the possibility that sales may actually exceed expectations, the Potters Guild should continue its recent financial successes in the coming year.
